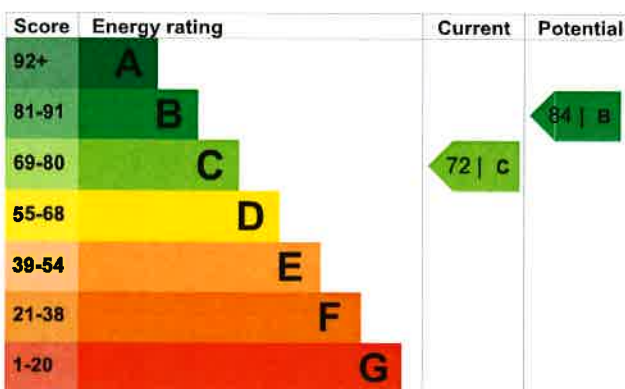

### Primary energy use

### Environmental impact of this property
