


Properties can be let if they have an energy rating from A to E.

## How this affects your energy bills

An average household would need to spend £462 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

#### Step 4: High heat retention storage heaters

Potential rating after completing steps 1 to 4	82 B
