There is also a regular bus service to outlying villages and to the County Town of Taunton which is approximately 7 miles distant with its main line railway station. The M5 Motorway can be accessed via Junction 26 just outside Wellington.



Outside, there is an attractive approach to the development with some resident and visitor parking and beautifully tended gardens, well stocked with a variety of mature flower and shrub borders. There are a number of seating areas and a lit pathway through towards the town centre and all of the local amenities on offer.

Occupants must be 60 years of age or over and have obtained the Estate Manager's approval for residency. The Service Charge is approximately £2,735.76 per year and includes the pull-cord emergency-alert system, Estate Manager services, management fee, window cleaning, maintenance and insurance of the buildings and gardens.
