



#### How this affects your energy bills

An average household would need to spend £996 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

Estimated energy needed in this property is:

- 7,488 kWh per year for heating

## Step 3: Hot water cylinder insulation

## Step 4: Hot water cylinder thermostat

Typical yearly saving	£77

# Step 5: Replace boiler with new condensing boiler

Typical installation cost	£2,200 - £3,000
Typical yearly saving	£159
Potential rating after completing steps 1 to 5	76 C
