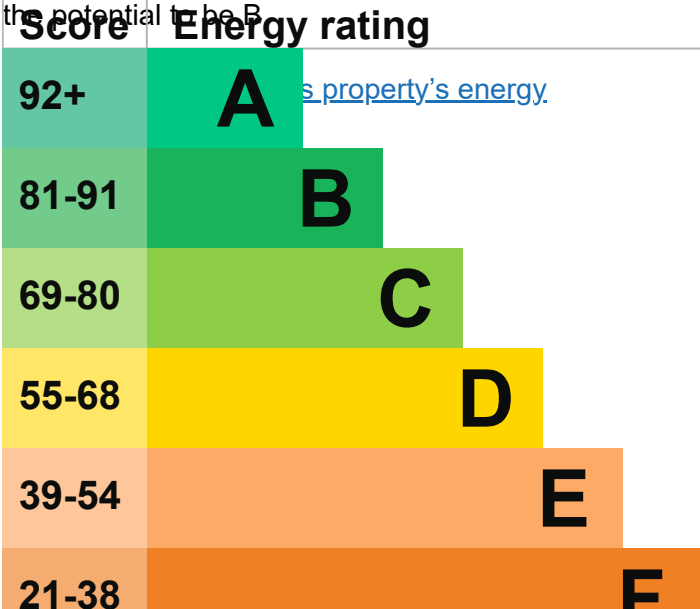

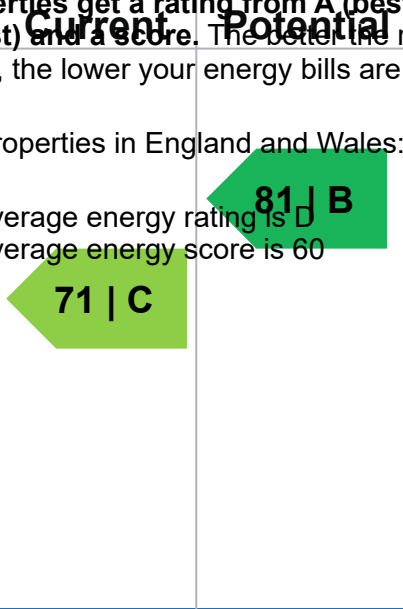
This property's current energy rating is C. It has the potential to be B.
